The amendments are to Chapters 1.1, General Administration, 1.2, Definitions, 1.3, Enforcement, 2.7, Special Planned Districts, Refinement Plans, Area Plans and Master Plans, 3.1, Lot, Parcel, and Block Design, Access and Circulation, 3.2, Landscaping, Street Trees, Fences and Walls, 3.5 Other Design Standards, 4.2, Minimum Development Standards Review, Site Plan Review and Design Review, 4.3, Land Divisions and Property Line Adjustments, and 4.5, Master Plans.
