REQUEST: Amendments to the Bend Development Code (BDC) relating to tree preservation and street tree and planter strip landscaping requirements. The amendments are to Chapters 1.1, General Administration, 1.2, Definitions, 1.3, Enforcement, 2.7, Special Planned Districts, Refinement Plans, Area Plans and Master Plans, 3.1, Lot, Parcel, and Block Design, Access and Circulation, 3.2, Landscaping, Street Trees, Fences and Walls, 3.5 Other Design Standards, 4.2, Minimum Development Standards Review, Site Plan Review and Design Review, 4.3, Land Divisions and Property Line Adjustments, and 4.5, Master Plans. There are also minor changes throughout for consistency and clarity.
