On December 18, 2024, the Bend City Council adopted Ordinance NS-2519, amending Bend Development Code Table 2.2.300, permitted and conditional uses in the Convenience Commercial Zone District. The adoption of this ordinance is the final local decision for the project referenced below. The ordinance becomes effective on January 17, 2025.
